**"ORDER"**

**Whereas** the petitioner Sh. Khem Singh, TGT Arts is working at GMS Thachadhar u/c GSSS Gadagusain, Distt. Mandi has filed CWP No **16153/2025** titled as Khem Singh Vs State of H.P and others before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 14.10.2025 when the same was finally disposed with the directions to respondents as under:-

*"Since it is quite apparent from the pleadings adduced on record by the respective parties that petitioner has already completed normal tenure at present place of posting coupled with the fact that transfer policy enables an employee to seek transfer from hard area to soft area or one of the stations of choice after completion of normal tenure of posting, this court sees no impediment in as much as issuing direction to the respondents to consider and decide pending representations of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy. Pending applications, if any, also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called to appear in this office for personal hearing on 22.12.2025 & was present on this date. During the course of hearing the petitioner was submitted that he is suffering from a permanent locomotor disability and requested to transfer/adjustment him either at GSSS Jarol / GSSS Shodhadhar / GSSS Janjehli /GSSS Thunag /GSSS Nihri Sunah, Distt. Mandi, against vacancy.

After perusal of the relevant record, it is revealed that Sh. Khem Singh, TGT Arts posted at GMS Thachadhar u/c GSSS Gadagusain, Distt. Mandi (i.e. Hard Area) since 23.02.2022 & as such his stay is complete. At present one post of TGT (Arts) is lying vacant at GSSS Jarol, Distt. Mandi, wherein about 130 students are enrolled.

Therefore, keeping in view the position stated above, the representation of the petitioner, Sh. Khem Singh, TGT Arts is being adjusted/transferred from GMS Thachadar u/c GSSS Gadagusain, Distt. Mandi to GSSS Jarol, Distt. Mandi, against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
