ORDER

In the matter of:

CWP No. 12777/2025-titled as Neeraj Koundal (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Neeraj Koundal, TGT (Med.) has filed CWP No. 12777/2025 titled as Neeraj Koundal V/s. State of H.P. in the Hon'ble High Court, and seeking his transfer from GHS, Dhar u/c GSSS, Jadera Distt. Chamba either to PM Shri GSSS, Marwari Distt. (Una) on retirement, GSSS, Kaloh Distt. (Una) PM Shree GSSS Kotla Behr Distt. (Kgr) or GHS, Ghagoh u/c GSSS, Daloh Distt. (Una). The case was listed before the Hon'ble High Court of H.P. on 07.08.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Petitioner is serving as TGT (Medical) at GHS Dhar, u/c GSSS Jadera Distt. Chamba. His case is that on completion of more than requisite tenure at the aforesaid hard and difficult are, he preferred representation on 24.06.2025 (Annexure P-2) to the respondents, seeking his transfer, but the respondents have not taken any action on the same till date.

Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law and as per applicable notification/policy within a period of two weeks from today. The decision so taken be also communicated to the petitioner."

As per the direction of the Hon'ble High Court the petitioner was called for personal hearing and attended the personnel hearing on 25.08.2025 during the hearing he stated that he is suffering from severe cardiac ailments and has undergone coronary angioplasty and requested to adjust him at District Kangra and District Una after completion of normal tenure at present place of posting.

From the perusal of record, it is found that Sh. Neeraj Koudal, TGT (Med.) is working at GHS, Dhar U/c GSSS, Jadera District (Chamba) since 22.02.2021 and has completed normal tenure at his present place of posting. At present one post of TGT (Med.) is lying vacant at GHS, Ghagoh Distt. Una.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Neeraj Koundal, TGT (Med.) is considered sympathetically and hereby transferred from GHS, Dhar Distt. Chamba to GHS, Ghagoh u/c GSSS, Daloh Distt. (Una) against vacancy, without TTA/JT on his own request. The representation of the petitioner is disposed of accordingly.

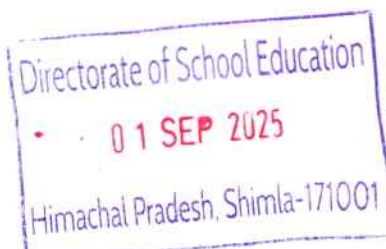
