OFFICE ORDER

In the matter of: CWP. No. 943/2026-titled as Sh. Raj Kumar, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Raj Kumar, Headmaster, who is presently working in GHS Najan, Distt. Kullu, H.P. has filed CWP No. 943/2026- titled as Raj Kumar Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Najan, Distt. Kullu to nearby his native place in Distt Hamirpur, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 09-01-2026, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. Though careful perusal of pleadings adduced on record by the petitioner, which are duly supported by affidavit, reveals that petitioner has not completed normal tenure of posting at present place of posting, but once Transfer Policy, formulated by the Government of Himachal Pradesh, enables an employee to seek transfer on medical grounds, this Court sees no impediment, inasmuch as issuing direction to respondents to consider and decide the pending representation of the petitioner (Annexure P-1) expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending application(s), if any, also stands disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 19.02.2026. He attended the same and submitted his representation in this office on 19.02.2026, vide which he has requested that he may be transferred from GHS Najan, Distt. Kullu, H.P. to nearby his native place in Distt. Hamirpur, on medical grounds, against vacancy, being caused due to retirement of present incumbent on 28-02-2026.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Najan, Distt. Kullu, H.P. since 10-12-2025. He has given three stations of his choice in District Hamirpur in which one post of Headmaster is being caused vacant due to retirement of present incumbent at GHS Dhirwin, Distt. Hamirpur on 28-02-2026. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GHS Najan, Distt. Kullu to GHS Dhirwin, Distt. Hamirpur, on medical grounds, against vacancy being caused due to retirement of present incumbent on 28-02-2026. These orders will be implemented after retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
