OFFICE ORDER

Whereas, Government of Himachal Pradesh has taken policy decision on 12.12.2003 that the mode of recruitment by contract appointment may also be prescribed in addition to other mode of recruitment in the Recruitment and Promotion Rules. Accordingly the contract provision was inserted in R&P Rules of Lecturer cadre on 11.06.2009. Thereafter in direct recruitment all appointments in direct quota have been made on contract basis.

And whereas, these posts were advertised by the Himachal Pradesh Subordinate Service Selection Board Hamirpur vide advertisement No. 13/2008 dated 28.08.2008 and advertisement No. 14/2009 dated 17.02.2009 for contract appointment on the basis of draft R&P Rules. The provision of contract appointment was finally notified in R&P Rules of Lecturer (School Cadre) on 11.06.2009. Feeling aggrieved petitioners have filed the following CWP's:-

And whereas, the Government has notified HP Recruitment and Conditions of Service of Govt. Employees Bill,2024 wherein it has been mentioned that after 12.12.2003 contractual will be entitled for service benefit after regularization only.

Now therefore, in view of facts and circumstances and going through the representations of petitioners and nothing was concealed from petitioners when posts were advertised and all 1404 posts were filled as per Govt approval. Now HP Government has notified Himahcal Pradesh Recruitment and Conditions of Service of Govt. Employees Act,2024 (Act No. 23 of 2025) the petitioners are not entitiled for benefit of regular appointment from initial contract appointment hence the claim is considered and rejected.
