ORDER

In the matter of: CWP No. 17653/2025- titled as Lavleen Kumar Vs. State of H.P. and others.

Whereas, Lavleen Kumar, TGT (NM) presently working in GHS Narwandhi u/c GSSS Sianj, Distt. Mandi has filed CWP. No. 17653/2025- titled as Lavleen Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Narwandhi u/c GSSS Sianj, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 13.11.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"4. True it is that petitioner has not completed normal tenure of posting at present place of posting, but once transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer on medical grounds from one station to other, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation dated 14.10.2025 (Annexure P-2), of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass High Court of H.P. appropriate order, taking note of the documents adduced on the record by the petitioner suggestive of the fact that he is not physically well. Pending applications, if any, also stand disposed of"

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.12.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Narwandhi u/c GSSS Sianj, Distt. Mandi to GHS Dugrain, u/c GMSSS Hatgarh, Distt. Mandi against vacancy on medical ground.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Narwandhi u/c GSSS Sianj, Distt. Mandi since 15.07.2024. At present, one post of TGT (NM) is lying vacant at GHS Dugrain, u/c GMSSS Hatgarh, Distt. Mandi.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Narwandhi u/c GSSS Sianj, Distt. Mandi to GHS Dugrain, u/c GMSSS Hatgarh, Distt. Mandi against vacancy without TTA/JT on medical ground.

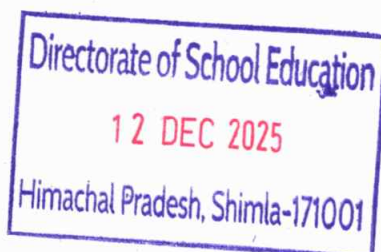
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
