The petitioner has filed CWP No. 2144/2026 titled as Smt. Satyawati,TGT(Sanskrit),Vs state of HP & others regarding her transfer from GMSSS,Sihunta District Chamba to District Kullu under 5% quota. The case of the petitioner was listed before the Hon'ble High Court on 26.02.2026, when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Having perused the averments made in the writ petition this petition, this petition is disposed of with the direction that let the authority decide the representation filed by te petitioner, appended with the petition as Annexure P-2 within a period of four weeks from today sympathetically, by passing a speaking order, after affording an opportunity of hearing to the petitioner. Pending miscellaneous application(s),if any,also stand disosed of accordingly."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 12th March.2026. The petitioner appeared before the undersigned on schedule date and time and heard in person. The petitioner has requested that she may kindly be transferred from GMSSS Sihunta,Distt.Chamba,to Distt. Kullu against vacancy, under 5% quota,(inter district transfer policy).

From the perusal of the record,it reveals that the petitioner working in GMSSS Sihunta Distt.Chamba since 30th Sep.2022 (Tribal/Hard area).At present,498 posts of shastri are sanctioned and out of these sanctioned posts about 28 posts of Shastri's are lying vacant in District Chamba.We need more teachers instead of transferring the teachers from District for smooth functioning of schools. Presently 99 students are studying in GMSSS Lyh District Chamba. If petitioner is transferred then, it will adversely affect the academic progress of the students studying in GMSSS Sihunta ,District Chamba.

In view of facts stated above, the request of the petitioner cannot be acceded at present stage and her representation is hereby rejected and disposed of accordingly.
