(Kgr.) since 12.04.22 and after completion of his normal tenure at present place of posting he was transferred to GHS, Bara Bhangal U/c GSSS, Bir Distt. (Kgr.) vice Sh. Rajesh Kapoor, TGT (Med.). GHS, Bara Bhangal falls in Hard area of District Kangra. The petitioner Sh. Sanjeev Kumar, TGT (Med.) has not served hard area in his service. Morevoer Sh. Sanjeev Kumar, TGT (Med.) has joined in GHS, Bhara Bhangal U/c Uttrala Distt. (Kgr.) on 26.05.2025 and having short stay at present place of posting.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12 "In view of the observations made by the Hon'ble high Court vide judgment dated 27.08.2007 in CWP No. 1105/2006 titled as Sushila Sharma, the Department may also ensure that every employee during his tenure of service, serves in Tribal/Hard Areas as well as Remote/Rural Areas.

Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of according

ORDER

CWP No. 9536/2025 titled as Sonika Kumari, TGT (Med.) Vs.

State of H.P. & others.

The Petitioner, Smt. Sonika Kumari, TGT(Med.) filed CWP No. 9536/2025 titled as, Smt. Sonika Kumari, TGT (Med) Vs. State of H.P. before the Hon'ble High Court of H.P. against her transfer from GHS, Bairi u/c GSSS, Jhiralri Distt. (Hmr.) to GSSS, Gada Kufri Distt. (Sml.) vice Smt. Seema Devi, TGT (Med.). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 02.07.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"The impugned office order dated 04.06.2025 (Annexure P-1) is quashed and set aside, but with directions to respondent No.2 to consider respective cases of transferring the petitioner and respondent No. 3 afresh in accordance with law keeping in view the observations made hereinabove. This exercise be carried out within a period of three weeks from today i.e. by 26.07.2025. Till such time, parties shall continue to remain posted at their present place of posting."

As per the direction of the Hon'ble High Court the petitioner and respondent were called for personal hearing and both the petitioner/respondent attended the personnel hearing on 17.07.2025. The respondent Smt. Seema Devi has requested to adjust her at GHS, Bairi u/c GSSS, Jhiralari/GHS, Malangan Distt. (Hmr.)/GHS, Bhadwar Distt. (Una.) against longer stayee by clubbing their stay due to her adverse family circumstances.

From the perusal of record pertaining to the case shows that Smt. Seema Devi, TGT (Med) was u/t from GSSS, Kulehra Distt. (Hmr.) to GSSS, Gada Kufri Distt. (Sml.) and adjusted at GHS, Bairi Distt. (Hmr.) vice Smt. Sonika Kumari, TGT (Med.) vide this Directorate letter of even no. dt. 04.06.2025 with the prior approval of competent authority. In GHS, Malangan Distt. (Blp.) Sh. Mustaq Ahmad has been working since 05.03.2024 and having short stay, but serving within the radius since 2017.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Sonika Kumari, TGT (Med.) is considered sympathetically and Smt. Seema Devi, TGT (Med.) is hereby transferred from GSSS, Gada kufri Distt. (Sml.) to GHS, Malangan Distt. (Blp.) vice Sh. Mustaq Ahmad TGT (Med.). Smt. Sonika Devi, TGT (Med.) is permitted to continue in GHS, Bairi Distt. (Hmr.). Keeping in view the position stated above, representation of the petitioner i.e Smt. Sonika Kumari, TGT (Med.) is disposed of accordingly.
