ORDER

In the matter of:- CWP No. 20136/2025-titled as Sapna Kumari, TGT (Arts) V/s. State of HP.


The petitioner has filed present CWP No. 20136 of 2025 titled as Sapna Kumari Vs State of HP in the Hon'ble High Court vide which she has sought transfer from GHS Bhadela u/c GSSS Mangli Distt. Chamba HP to her choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 19.12.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 16.01.2026 and appeared before the undersigned on the said date. During the hearing, the petitioner, Smt. Sapna Kumari, TGT (Arts), submitted fresh representation and stated that she is working at GHS Bhadela u/c GSSS Mangli Distt. Chamba and requested for transfer/adjustment either at GSSS Rakkar (Dharamshala), GHS Totarani, GBSSS Dharamshala Distt. Kangra on account of completion of normal tenure and her medical conditions.

From the perusal of the record, it is found that Smt. Sapna Kumari, TGT (Arts), is working at GHS Bhadela u/c GSSS Mangli Distt. Chamba since 22.02.2022, she has completed her normal tenure at present place of posting and one post of TGT (Arts) is GHS Totarani Distt. Kangra wherein 54 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Smt. Sapna Kumari, TGT (Arts) posted at GHS Bhadela u/c GSSS Mangli Distt. Chamba is hereby transferred/adjusted at GHS Totarani Distt. Kangra against vacancy without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
