Provided this condition is not applied to Bonafide Himachalis. Candidates who have not passed Teacher Eligibility Test from Board of School Education Dharamshala are also not eligible for the post.

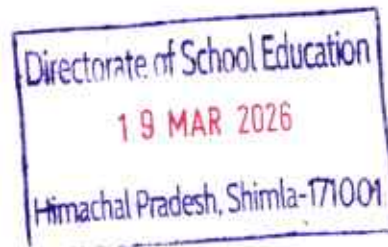
