## ORDER

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP N. 16475/2024 Pushpa Sharma, TGT (Arts) V/s State of H.P. on 30-12-2024, the petitioner was called for personal hearing on 22-02-2025 and appeard before the undersigned on scheduled date. The petitioner has stated that she has completed her normal tenure in difficult area and her husband is also working in Education department as TGT(Medical) therefore, requested for her transfer either to GSSS Tandoo, GHS Bijani, GSSS Sadiana, GSSS Bhangrotu (Girls), GSSS Badog, GSSS Bari, GSSS(B) Mandi, GHS Kathalag, GSSS Talyahar, against vacancy/longer stayee.

From the perusal of record, it is found that Smt. Pushpa Sharma, TGT (Arts) is working at GSSS Cheuni (Difficult area) District Mandi since 31-03-2022 and has completed her normal tenure in difficult area. At present there is no post of TGT (Arts) is lying vacant in desired schools, but one post of TGT (Arts) is going to be vacant at GSSS Tandoo, District Mandi, due to retirement of present incumbent on 30-06-2025.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Pushpa Sharma, TGT (Arts) is considered sympathetically as per transfer policy clause 5.4 "concession to couples case" working under H.P. Government and she is hereby transferred from GSSS Cheuni, District Mandi to GSSS Tandoo, District Mandi against vacancy, being caused due to the retirement of present incumbent on 30-06-2025, without TTA/JT, The petitioner will join after superannuation of present incumbent i.e. after 30-06-2025. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
