OFFICE ORDER

Whereas, the Department appointed TGT (Arts/NM/Medical) on contract basis vide office order No. EDN-H(2)B(2)5&6/2017-TGT-Arts (Batchwise) dated 29.09.2017, No. EDN-H(2)B(2)5&6/2017-TGT-Non-Med. (Batchwise) dated 29.09.2017 and No. EDN-H(2)B(2)5&6/2017-TGT-Medical (Batchwise) dated 29.09.2017 and 15 days joining time was allowed to all the appointed candidates. Consequently, some candidates joined on the same day i.e. on 29.09.2017 while many other candidates joined between 03.10.2017 to 13.10.2017 being holidays on 30.09.2017, 01.10.2017 & 02.10.2017.

And whereas, Department of Personnel, Government of Himachal Pradesh has issued instructions for the year 2020 for regularization of contract appointees in the Government Departments vide letter No. PER(AP)C-B(2)-1/2019 dated 22.04.2020. The cut off dates for regularization of contractual appointees who had completed three years of continuous service as on 31.03.2020 and 30.09.2020 were fixed by the Government. The regularization was subject to certain terms and conditions and after observing all codal formalities. Therefore, the TGTs who joined on 29.09.2017 and had completed 03 years of continuous service as on 30.09.2020 were regularized on 26.10.2020 after observing all codal formalities.

And whereas Department of Personnel Government of Himachal Pradesh has issued instructions for the year 2021 for regularization of contract appointees in the Government Department vide letter No. PER(AP)C-B(2)-1/2019 dated 31.03.2021. The cut off dates for regularization of contractual appointees who had completed three years of continuous service as on 31.03.2021 and 30.09.2021 were fixed by the Government. Therefore, the TGTs who joined between 03.10.2017 to 13.10.2017 (i.e. within the joining time) and had completed 03 years of continuous service as on 31.03.2021 were regularized on 30.04.201 after observing all codal formalities.

And whereas, Department of Personnel Government of Himachal Pradesh vide letter No. PER(AP)-C-B(2)-1/2019 dated 06.04.2022 has issued instructions and decided to condone the period of holidays only in such cases where the offer/order of appointment was made/issued on the last working day of the month of March or September, as the case may be, and holidays falls immediately thereafter restricting the incumbents to give joining in that particular month of appointment. The date of issuance of offer/order of appointment has been reckoned as cutoff date for their regularization and such period and joining has also considered as condoned inter-ser. Accordingly, the Department has allowed benefit of regularization to 427(295+132) appointees w.e.f. 20.10.2020 who were offered appointment on dated 29.09.2017 and joined their duties in the stipulated time period (i.e. 15 days joining time) vide office order No. EDN-H(2)B(2)34/2023 Regularization dated 17.07.2023 & 05.01.2024.

And whereas, the Department has again received 37 cases of such TGTs who were offered appointment on contract basis on dated 29.09.2017 for benefit of regularization as per Government letter dated 06.04.2022 and the Department constituted a screening committee vide office order No. EDN-H(2)B(2)-34/2023-Regularisation (Contract) dated 08.11.2023 to verify the fact that whether the concerned TGTs have joined in the allotted station in stipulated time period or not.

And whereas, during scrutiny of the cases of the TGTs, the screening committee has found that 32 TGTs have joined in the allotted station within stipulated time period and the appointment orders of 5 TGTs were issued after 05.10.2017, hence, they are not eligible for their regularization w.e.f. 01.10.2020. Accordingly, the screening committee has recommended the names of 32 TGTs for regularization.

Now, therefore, as per recommendation of the screening committee, the services of the following TGTs appointed on contract basis on dated 29.09.2017 are hereby considered regularized in the minimum of pre-revised pay of Rs. 10300+3600 Grade pay w.e.f. 26.10.2020 i.e. from the date their counterparts were regularized instead of 30.04.2021 after taking into consideration of their 03 years continuous service as on 30.09.2020:-
