ORDER

In the matter of: CWP No. 2575/2026- Sh. Madan Lal, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Madan Lal, TGT(NM) previously working in GMS Chentti u/c GSSS Balakrupi, Distt. Kangra has filed CWP No. 2575/2026 titled as Sh. Madan Lal, TGT(NM) Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 05.03.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

“Without interfering with the impugned transfer order, this petition is disposed of with the direction that in the event of the petitioner approaching the Authority by way of a fresh representation within one week from today, let appropriate decision be taken thereupon within two weeks from the date of receipt of the representation by passing a reasoned and speaking order. The petitioner is at liberty to avail the leave of kind due and he may not be forced to join at new station till decision on the representation. Pending miscellaneous application(s), if any also stand disposed of accordingly.”

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Dagera u/c GSSS Gharana or GMS Bheri u/c GSSS Balakrupi or GMS Jangel u/c GSSS Alampur or GSSS Balakrupi or GMS Raipur u/c GSSS Lambagaon, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Chentti u/c GSSS Balakrupi, Distt. Kangra to GMS Guwar u/c GSSS Guwan, Distt. Chamba vice Sh. Arvind Kumar, TGT(NM) vide order dated 11.02.2026 with the prior approval of the competent authority after completion of his normal tenure of three years. At present, vacancies are not available in the above-mentioned schools where petitioner requested for transfer. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.
