ORDER

In the matter of: CWP No. 15465/2024-titled as Munshi Ram, TGT (Arts) V/s. State of Himachal Pradesh.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP N. 15465/2024 Munshi Ram, TGT (Arts) V/s State of H.P. on 18-12-2024, the petitioner was called for personal hearing on 22-02-2025 and appeared before the undersigned on scheduled date. The petitioner has requested to be transferred from GHS Chet u/c GSSS Cheuni, District Mandi either to GMS Sarli u/c GSSS Panjain, GHS Riur u/c GSSS Rewalsar, GMS Sangehar u/c GSSS Sidhyani, GSSS Galma, Distt. Mandi or GSSS Kullu, District Kullu, against vacancy/longer stayee.

From the perusal of record, it is found that Sh. Munshi Ram, TGT (Arts) is working at GHS Chet u/c GSSS Cheuni (Difficult area) District Mandi since 21-05-2018 and having 06 years stay at his present place of posting. Keeping in view the position stated above, representation of the petitioner i.e Sh. Munshi Ram, TGT (Arts) is considered sympathetically and he is hereby transferred from GHS Chet u/c GSSS Cheuni, District Mandi to GMS Sarli u/c GSSS Panjain, District Mandi against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
