**ORDER**

In the matter of: CWP No. 632/2026- Sh. Ashish Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Ashish Kumar, TGT(NM) presently working in GHS Dhalli u/c GSSS Piran, Distt. Shimla has filed CWP No. 632/2026 titled as Sh. Ashish Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Dhalli u/c GSSS Piran, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 07.01.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"In the impugned order, respondent No.2, though records that the petitioner had prayed for his transfer from his current place of posting to any of the stations mentioned by him in his representation, which were statedly either lying vacant or on grounds of longer stayees. However, the impugned order does not assign any reason as to why the petitioner could not be accommodated at the stations indicated by him. The impugned order dated 18.10.2025 (Annexure P-11), being bereft of reasons and non-speaking, is quashed and set aside. The petitioner is at liberty to file a fresh representation to the respondents/competent authority for his transfer/adjustment within two weeks from today. In case such representation is preferred by the petitioner, the same shall be considered and decided by the competent authority, in accordance with law within two weeks thereafter by passing a speaking order strictly in consonance with Ashish Kumar2. The order so passed be communicated to the petitioner. The writ petition is disposed of in above terms. Pending miscellaneous application(s), if any, shall also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 09.02.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner stated that he is a physical disabled person and also requested that he may be transferred from GHS Dhalli u/c GSSS Piran, Distt. Shimla to GSSS Pir Saluhi or GHS Phakloh or GMS Tikkar u/c GSSS Par Saluhi, Distt. Kangra on medical grounds.

After perusal of relevant record, it is revealed that the petitioner has been working in GHS Dhalli u/c GSSS Piran, Distt. Shimla since 03.06.2025. At present, one post of TGT(NM) is lying vacant at GHS Phakloh, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Dhalli u/c GSSS Piran, Distt. Shimla to GHS Phakloh, Distt. Kangra, against vacancy, without TTA/JT, on his own request on medical grounds.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
