**ORDER**

In the matter of: CWP No. 13873/2025- Sh. Parveen Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Parveen Kumar, TGT(NM) presently working in GHS Gulabgarh u/c GSSS Jamniwala, Distt. Sirmour has filed CWP No.13873/2025 titled as Parveen Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred at one of the stations of his choice in Distt. Una/Kangra. The case of the petitioner was listed before the Hon'ble High Court on 29.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"Having regard to the nature of prayer and order proposed to be passed, this Court sees no necessity to call for reply on behalf of the respondents, who are otherwise represented by Mr. Vishal Panwar, learned Additional Advocate General. Learned Additional Advocate General states that mere completion of normal tenure of posting at one station may not be a ground to seek transfer, rather it is the sole prerogative of the employer to post an employee at a particular station. Having taken note of the fact that petitioner has already completed more than nine years at present place of posting, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh provides for minimum tenure of three years at one station, this Court sees no impediment in issuing direction to the respondents to consider and decided the representation dated 21.08.2025 (Annexure P-7) of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note transfer policy. Pending applications, if any, also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 15.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Gulabgarh u/c GSSS Jamniwala, Distt. Sirmour to GSSS Kinnu, Distt. Una or GMS Nari u/c GHS Ghati Bilwan, Distt. Kangra against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GHS Gulabgarh u/c GSSS Jamniwala, Distt. Sirmour since 18.12.2021 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GSSS Kinnu, Distt. Una.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Gulabgarh u/c GSSS Jamniwala, Distt. Sirmour to GSSS Kinnu, Distt. Una, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration.
