Whereas, Smt. Tashi Palmo, DPE/ Lect. Phy. Education preferred CWP No.9533/2025 titled as Tashi Palmo Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GSSS Sarpara, Distt. Shimla to to nearby his native place in Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 18-06-2025 when the Hon'ble High Court has passed the following orders:-

"3. Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide her representation, expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of provisions contained in the transfer policy. Pending application(s), if any, also stand disposed of"

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 15-11-2025. She attended the same and submitted her representation in this office on 15-11-2025, vide which She has requested that She is on verge of retirement on 30-04-2027 and She may be transferred from GSSS Sarpara, Distt. Shimla, H.P.(Hard Area) to soft area at GSSS Kinnu, Distt. Shimla, H.P, against longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Sarpara, Distt. Shimla, H.P. (Hard Area) since 14-03-2024 and has almost completed two years stay at his present place of posting. The petitioner has already served hard area at GSSS Ganvi, Distt. Shimla, H.P. The petitioner is going to be retire on 30-04-2027. One Sh Durga Parsad, DPE/ Lect. Phy Education is working in GSSS Kinnu, Distt. Shimla since **08-01-2015**. The petitioner has given willingness for her transfer to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and She is hereby transferred in condonation of short stay/without TTA/JT from GSSS Sarpara, Distt. Shimla to GSSS Kinnu, Distt. Shimla, H.P vice Sh. Durga Parsad, DPE/ Lect. Phy Education. With TTA/JT to Sh. Durga Parsad, DPE/ Lect. Phy Education. The representation of the petitioner is disposed of accordingly.
