In the matter of: CWP No. 12571/2025- titled as Ajay Kumar, Vs. State of H.P. and others.

Whereas, Ajay Kumar, TGT (NM) presently working in GHS Seri u/c GSSS Pujarli-3, Distt. Shimla has filed CWP. No. 12571/2025- titled as Ajay Kumar, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GHS Seri u/c GSSS Pujarli-3, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 04.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Consequently, in view of the above, present petition is allowed and impugned order dated 24.07.2025 (Annexure P-6) is quashed and set aside. Respondents are directed to consider and decide the representation of the petitioner afresh strictly in terms of order passed by this Court in CWP No. 3927 of 2025 as well as observation made hereinabove expeditiously, preferably within three weeks. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 03.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GHS Seri u/c GSSS Pujarli-3, Distt. Shimla to GSSS Bhatoli Phakorian or GSSS Kathog or GSSS Kherian or GMS Lohna u/c GSSS Palampur or GMS Patti u/c GSSS Rajpur, Distt. Kangra against vacant post.

After perusal of the relevant record, it is revealed that the petitioner was appointed as TGT (NM) on contract basis on 26.02.2022 at GHS Seri u/c GSSS Pujarli-3, Distt. Shimla and has completed his normal tenure of three years at present place of posting. At present, one post of TGT (NM) is lying vacant at GSSS Bhatoli Phakorian, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GHS Seri u/c GSSS Pujarli-3, Distt. Shimla to GSSS Bhatoli Phakorian, Distt. Kangra against vacancy without TTA/JT as per his request.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
