ORDER

In the matter of: CWP No. 265/2026- Sh. Parveen Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Parveen Kumar, TGT(NM) presently working in GMS Chikhar u/c GSSS Sandhu, Distt. Shimla has filed CWP No.265/2025 titled as Parveen Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Chikhar u/c GSSS Sandhu, Distt. Shimla to one of the stations of his choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 06.01.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representations dated 14.04.2024 & 22.10.2025(Annexure P-1 & P-2 colly) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, besides affording opportunity of hearing to the petitioner, shall also take note of Clause 9 of transfer policy dated 10th July, 2013 as well as judgment dated 30.10.2021 passed by Division Bench of this Court in case tilted Tara Tegwan vs. State of Himachal Pradesh and others, and pass detailed order thereupon. The respondents, while passing the order, shall also note of the fact that daughters of the petitioner are studying in Class 10+2 and 8th at Hamirpur. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.01.2026, but petitioner did not appear. He appeared for personal hearing on 27.01.2026 and requested that he may be transferred from GMS Chikhar u/c GSSS Sandhu, Distt. Shimla to GMS Khirki u/c GSSS Karot, Distt. Hamirpur, against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Chikhar u/c GSSS Sandhu, Distt. Shimla since 03.10.2017 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at GMS Khirki u/c GSSS Karot, Distt. Hamirpur.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Chikhar u/c GSSS Sandhu, Distt. Shimla to GMS Khirki u/c GSSS Karot, Distt. Hamirpur, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
