ORDER

Whereas, Smt. Savita, TGT (NM) presently working in GHS Talla, u/c GSSS Tundi, Distt. Chamba has filed CWP No. 16489/2025 titled as Savita, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that she may be transferred from GHS Talla, u/c GSSS Tundi, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 17.10.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order

"True, it is that it is sole prerogative of the employer to post an employee anywhere in the State, but once transfer policy formulated by State of Himachal Pradesh, itself prescribes for completion of minimum tenure of three years at one place and besides this, employee can also seek transfer on the ground of adverse family circumstances, this Court sees no impediment in as much as issuing direction to the respondents to consider and decide representation of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy as well as observation made herein above. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.11.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GHS Talla, u/c GSSS Tundi, Distt. Chamba to GSSS Peri or GMS Sudher u/c GSSS Gharoh or GMS Siholpuri u/c GSSS Shahpur or GMS Basnoor u/c GSSS Rait or GHS Ketlu u/c GSSS Rajol, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GHS Talla, u/c GSSS Tundi, Distt. Chamba since 13.10.2022 and completed her normal tenure at this station. One, Smt. Anju Rani, TGT (NM) has been working in GMS Ketlu u/c GSSS Rajol, Distt. Kangra since 26.09.2022 and has completed her normal tenure of three years at present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is transferred from GHS Talla u/c Tundi, Distt, Chamba to GMS Ketlu u/c GSSS Rajol, Distt. Kangra without TTA/JT vice Anju Rani, TGT (NM) and vice versa with TTA/JT.
