ORDER

In the matter of: CWP No. 1826/2026 titled as Jeevan Singh, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Jeevan Singh, TGT (NM) presently working in GMS Thana Kasoga u/c GSSS Panjahal Distt. Sirmour has filed CWP No. 1826/2026 titled as Jeevan Singh, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that he may transferred from Thana Kasoga u/c GSSS Panjahal Distt. Sirmour to one of the stations of his choice in Distt. Una. The case of the petitioner was listed before the Hon'ble High Court on 12.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Consequently, the respondents are directed to decide the representation as filed by the petitioner positively within a period of three weeks from today. Before passing any order, the petitioner shall be personally heard in the matter and thereafter the order, if any, shall be passed and same shall be communicated to him. 4. Needless to say, that this Court has not expressed anything on the merits of the case and the respondents are at liberty to take decision in accordance with law. 5. Accordingly, the petition stands disposed of, so also the pending application, if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 05.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Thana Kasoga u/c GSSS Panjahal Distt. Sirmour to GMS Amroh u/c GSSS Ambehra or GMS Chougath Sanhal u/c GSSS Proian Kalan or GSSS Amb, Distt. Una against vacancy or longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Thana Kasoga u/c GSSS Panjahal Distt. Sirmour since 03.10.2017. The said teacher has completed his normal tenure of three years at present place of posting. At present, one post of TGT (NM) is lying vacant at GMS Amroh u/c GSSS Ambehra, Distt. Una.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Thana Kasoga u/c GSSS Panjahal, Distt Sirmour to GMS Amroh u/c GSSS Ambehra, Distt. Una against vacancy without TTA/JT as per his request.

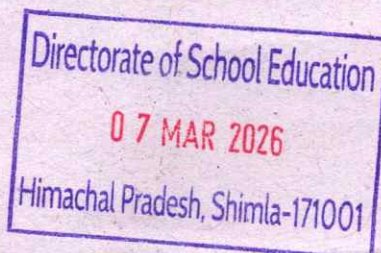
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
