In the matter of: CWP No. 7493/2025- titled as Parveen Kumar, Vs. State of H.P. and others.

Whereas, Parveen Kumar, TGT (NM) presently working in GSSS Raan Distt. Chamba has filed CWP. No. 7493/2025- titled as, Parveen Kumar Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Raan, Distt. Chamba to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 07.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Since petitioner has already completed more than three years in one particular area and the transfer policy prescribes transfer of an employee after his/her having completed three years of service at one place of posting, coupled with the fact that petitioner has already filed representation to the competent authority for redressal of his grievance, this Court, without going into the merits of the case, disposed of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner (Annexure P-4) expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereafter taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Raan, Distt. Chamba to GMS Suknara u/c GSSS Nagrota surian or GMS Ludrete u/c GSSS Bariyal of GSSS Sakri or GSSS Spail or GSSS Bilaspur or GMS Bantungali u/c GSSS Spail or GSSS Baldoa, Distt. Kangra against vacancy being caused due to retirement of present incumbent or against vacancy or against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was appointed as TGT (NM) at GSSS Raan, Distt. Chamba (Hard Area) since 25.02.2021 the said teacher has completed his normal tenure of three years at present place of posting. At present, one post of TGT (NM) is going to be vacant at GMS Bantungli u/c GSSS Spail on 31.10.2025 due to retirement of present incumbent.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Raan, Distt. Chamba to GMS Bantungli u/c GSSS Spail, Distt. Kangra against vacancy being caused due to retirement of present incumbent on 31.10.2025, on his own request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
