## **ORDER**

Whereas, Sh: Pradeep Kumar, Lecturer (School-New) (Economics) was filed CWP No. 10989/2025 before the Hon'ble High Court seeking therein his transfer from GSSS Ghiri, Distt. Mandi to GSSS Killing, Distt. Mandi against vacancy being caused due to retirement of present incumbent on 31.08.2025, on account of certain family circumstance as well as medical ground of his mother and himself also.

The case was listed before the Hon'ble Court on 10.7.2025 when the case was disposed of with the following directions:-

"Looking to the nature of the grievance raised in this writ petition, it would in the interest of justice to direct Competent Authority to consider and decide the aforesaid representation dated 21.06.2025 (Annexure P-3) of the petitioner in accordance with law and as per applicable policy within a period of three weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner".

And whereas, as per the direction passed by the Hon'ble High Court regarding deciding his pending representation dated 21.06.2025 petitioner was called for personal hearing on 30.07.2025. During the course of hearing, petitioner has requested he is unable to continue at GSSS Ghiri (Mandi) due to medical condition as he is suffering from "Ratina Pigmatosa" in both eyes and his mother is also suffering from "Overian Cancer" and her treatment is undergone from Shri Lal Bahadur Shastri Medical College, Nerchowk, Mandi and his father is 81 years and also suffering from old age ailments and further requested to transfer him to GSSS Killing (Mandi) against vacancy being caused due to retirement of present incumbent on 31.08.2025 in view of his said circumstances.

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically on medical ground and the petitioner i.e. Sh. Pradeep Kumar, Lecturer (School-New) (Economics) is being transferred from GSSS Ghiri (Mandi) to GSSS Killing (Mandi) against vacancy being caused due to retirement of present incumbent on 31.08.2025 without TTA/JT as per petitioner request.

Note:- These orders shall come into force on or after 01.09.2025.

With these observations, representation stands disposed of.
