ORDER

In the matter of:

CWP No. 10002/2025 titled as Malti, TGT (NM) Vs. State of H.P. & others.

Whereas, Smt. Malti, TGT (NM) previously working in GMS Dhagwar u/c GSSS Passu, District Kangra has filed CWP No. 10002/2025 titled as Malti, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that she may be adjusted at one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 21.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

In view of above, this writ petition is disposed of as withdrawn. It goes without saying that in case the petitioner prefers a representation to the respondents/ competent authority citing adverse family circumstances within three days from today, the same shall be considered and decided in accordance with law and applicable transfer policy expeditiously, preferably within two weeks thereafter. The decision so arrived at shall also be communicated to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 25.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be adjusted at GSSS Jasai or GSSS Paisa or GHS Tripal or GSSS Kasba Narwana or GHS Kand or DIET Dharamsha or GHS Sukkar or GSSS Ghaniara, GMS Dain U/c GSSS Dheera, Distt. Kangra, against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Dhagwar u/c GSSS Passu, Distt. Kangra to GSSS Tangling, Distt. Kinnour vide order dated 10.06.2025 with the prior approval of the competent authority. One, Sh. Rakesh Kumar has been working in GMS Dain u/c GSSS Dheera Distt. Kangra since 29.09.2023. His previous place of posting at GMS Thalehar u/c GSSS Gaggal Distt. Kangra where he worked 24.12.2020 to 29.09.2023 and has completed his normal tenure of three years within the radius of 30 KM.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby adjusted without TTA/JT at GMS Dain u/c GSSS Dheera Distt. Kangra vice Sh. Rakesh Kumar, TGT (NM) (as he has been working there since 24.12.2020 within the radius of 30KM) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
