ORDER

In the matter of:-

CWP No. 10330/2025-titled as Sudesh Dogra, TGT (Arts) V/s. State of Himachal Pradesh.

The petitioner has filed present CWP No. 10330/2025 titled as Sudesh Dogra, TGT (Arts) V/s State of H.P. in the Hon'ble High Court against her transfer order dated 07.05.2025 and she has sought her adjustment as she is under transfer from GSSS Bhaderwar (MND) to GHS Chet u/c GSSS Cheuni (MND) vice Sh. Vijay Kumar, TGT(Arts) and vice versa basis on dated 07.5.2025. The case was listed before the Hon'ble High Court of H.P. on 27.06.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"In view of above, this writ petition is disposed of with liberty to the petitioner to furnish a fresh representation to respondent No.2/competent authority for her suitable adjustment within two days from today, whereafter, the same shall be considered and decided by respondent No.2/competent authority in accordance with law and applicable transfer policy within a period of ten days thereafter, i.e by or before 10.07.2025. The decision so arrived at shall also be communicated to the petitioner. It is made clear that this order shall not come in the way of joining of respondent No.3 in terms of transfer order dated 07.05.2025."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 18.7.2025 and appeared before the undersigned on the scheduled date. The petitioner has requested transfer/adjustment as she is under transfer from GSSS Bhaderwar (MND) to GHS Chet u/c GSSS Cheuni (MND) either to GSSS Nabahi/GSSS Rakhoh/GSSS Rissa/GMS Khudla Distt Mandi/GHS Patnaun (HMR) /GSSS Bhukar (HMR)/GSSS Chamboh(HMR), citing that her husband is also working as LT in Education department and as per the transfer policy clause 5.4 concession to couples who are working under H.P. Govt.

From the perusal of record, it is found that Smt. Sudesh Dogra, TGT (Arts) was transferred from GSSS Bhaderwar (MND) to GHS Chet u/c GSSS Cheuni (MND) vice Sh. Vijay Kumar, TGT(Arts) and vice versa basis on dated 07.5.2025 and at present no post of TGT (Arts) is lying vacant in the petitioner choice of Schools, however one Sh. Ashok Kumar, TGT (Arts) is working at GSSS Rakhoh Distt Mandi since 16.05.2025 and having short stay but serving within the radius of 30 kilometers.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and as per transfer policy clause 5.4 "concession to couples case" the petitioner Smt. Sudesh Dogra, TGT (Arts), who is u/t to GHS Chet u/c GSSS Cheuni Distt Mandi is hereby adjusted at GSSS Rakhoh Distt Mandi Distt. Mandi vice Sh. Ashok Kumar, TGT (Arts) who may further be transferred to GHS Chet u/c GSSS Cheuni Distt Mandi, by clubbing his previous place of postings tenure (with TTA/JT to Sh. Ashok Kumar). The representation of the petitioner in the present CWP stands disposed of accordingly.
