## Order

In the matter of:

CWP No. 7856/2025-Sudesh Dogra, TGT (Arts) V/s. State of Himachal Pradesh.

In compliance of Hon ble High Court order in CWP No. 7856/2025 the petitioner representation was decided and rejected as there is/are no vacancy in choice of stations.

Now, the respondent No. 3 Sh. Vijay Kumar, TGT (Arts) posted at GHS Chet u/c GSSS Cheuni (Mandi) has represented that on dated 13.5.2025 the Hon'ble Court in order had categorically held that upon the disposal of the representation of petitioner Smt. Sudesh Dogra, TGT (Arts) the respondent No. 3 i.e Vijay Kumar, TGT (Arts) shall be permitted to join at GSSS Bhaderwar Distt Mandi in place of Smt. Sudesh Dogra. The operative portion of the order/judgment is as under:-

"Having regard to the aforesaid submissions, but without interfering with the transfer of respondent No.3 under the impugned order, this writ petition is disposed of by permitting the petitioner to prefer a representation to respondent No.2/Competent Authority for her suitable adjustment. In case such a representation is made within three days, the same shall be considered and decided by the Competent Authority, in accordance with law and as per applicable transfer policy, within a week thereafter. Copy of decision so taken, be communicated to the petitioner. Implementation of office order dated 07.05.2025 (Annexure P-5) shall be deferred qua the petitioner and respondent No.3 till decision of the above representation. It is made clear that in case petitioner does not represent within the aforesaid period, the limited protection granted to her under this order shall automatically stand vacated.

Upon decision of petitioner's representation in the manner aforesaid, respondent No.3 shall be permitted to join at the place of the petitioner, in terms of the impugned office order."

Keeping in view of above narrated facts, the representation of Sh. Vijay Kumar, TGT (Arts) is considered and the transfer order issued vide this Directorate letter dated 07.05.2025 vide which the respondent No.3 Sh. Vijay Kumar, TGT (Arts) posted at GHS Chet u/c GSSS Cheuni (Mandi) transferred to GSSS Bhaderwar Distt Mandi vice Smt. Sudesh Dogra, TGT (Arts) and vice versa is hereby implemented and the joining/relieving of Sh. Vijay Kumar, TGT (Arts) be accepted immediately. All the concerned intimated accordingly
