Whereas, the petitioner Ram Chander, Lect. Pol. Science is working at GSSS Badhal (SML). Feeling aggrieved he filed CWP No. 8977/2025 titled as Ram Chander vs State of H.P. before the Hon'ble High court. This petition was listed before Hon'ble High Court on dated 29.05.2025. when the same was finally disposed with the directions to respondents as under.

Consequently, in view of the aforesaid fair stand adopted by learned Additional Advocate General, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the representation of the petitioner (Annexure P3) expeditiously, preferably within a period of four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass speaking orders thereafter, pending applications if any, stand disposed of."

And whereas, upon passing of above directions, petitioner has submitted his representation on dated 02.06.2025 vide which he has requested to adjust him at the choice of stations i.e. GSSS Tangling (KNR) against vacancy being a couple case as his wife is working at GPS Kalpa-II as a JBT Teacher as per clause 5.4 of transfer policy effort should be made to post both spouses at the same location.

And whereas, that the matter has been examined and found that the post of Lect. Pol. Science lying vacant at Tangling (KNR) but petitioner is not completed his normal tenure at present place of posting and enrolment is also 16 at GSSS Badhal (SML) and there is only 03 student enrolled at GSSS Tangling (KNR) in the said subject and as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.

ORDER

Whereas the petitioner namely Rajinder Kumar, Lect(History) was transferred from GSSS Kangoo (Hamirpur) to GSSS Sheran (Solan) vice Veena Rani, Lect(History) and vice versa vide this office order No. EDN -HE(26)B(6)13/2025-History dated 26.04.2025. In compliance to these orders the petitioner has joined at GSSS Sheran(Solan) on 03.05.2025 and he also filed CWP No. 8384/2025 titled as Rajinder Kumar vs State of HP before the Hon'ble High Court seeking there in relief regarding his suitable adjustment in view of 50% physical disability of the petitioner, which was listed on dated 21.05.2025 when the Hon'ble Court has given following directions as under:-

"Keeping that in view and without interfering with the transfer of respondent No. 4 under the impugned order, this writ petition is disposed of with direction to the respondent to consider case of the petitioner for his transfer afresh and also to decide his representation dated 03.05.2025 in accordance with law and as per applicable policy within a period of two weeks from today. Ordered accordingly. The order so passed be also communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application if any."

And whereas, upon passing of order dated 21.05.2025, the representation from the petitioner has been received and he was called for personal hearing on 24.06.2025. During the course of hearing and in his representation he has requested that however he has already joined at his transfer station i.e GSSS Sheran (Solan) but he is 50% Locomotive Disability and he has only one hand. Due to this he always needs help in his daily routine work hence, he is unable to serve at GSSS Sheran (Solan) and also due to his adverse family circumstances it is very difficult to manage as said station is very far from his native place and requested to adjust him at GSSS Sohari (Hamirpur) against vacancy being caused due to retirement of present incumbent on 31.08.2025.

And whereas, as per direction passed by the Hon'ble Court as above, request of the petitioner has been considered and found that however the petitioner has already joined at his transfer station i.e GSSS Sheran(Solan) on 03.05.2025 but keeping in view his physical disability, the request of the petitioner is being allowed/considered to GSSS Sohari (Hamirpur).

Now therefore, after taking into account the above discussed detailed facts and circumstances the petitioner i.e. Sh. Rajinder Kumar, Lect(History) is hereby transferred in condonation of short stay from GSSS Sheran (Solan) to GSSS Sohari(Hamirpur) against vacancy being caused due to retirement of present incumbent on 31.08.2025 without TTA/JT. These order shall come into force on or after 01.09.2025.

Hence the representation stands disposed of.
