(Regarding re-fix the pay with all consequential benefit)

The petitioner has filed the present Civil Writ Petition before the Hon'ble High Court with regard to stepping up of their pay with their junior Sh. Gyar Singh Negi alongwith all consequential benefit in terms of the judgment passed by this Court.

The said case was listed before the Hon'ble High Court of H.P. on different dated when the following orders was passed:-

“Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of with direction to respondent No.2/ competent authority to consider and decide the aforesaid representation of the petitioner dated 18.08.2025 (Annexure P-5) in accordance with law, keeping in view the above-decisions as also the decisions mentioned by the petitioner in his representation, within a period of six weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any”

Whereas, the case of the petitioner was examined in this Directorate and found that the petitioners Sh. Parveen Kumar, Dinesh Kumar, Mahesh Kumar Sharma have already availed three financial enhancement/ upgradation during his first 14 years of service, hence, they are not entitled for any other benefit under ACPs. The examination of the case of Gyar Singh Negi reveals that he was granted benefit under ACPs (4-9-14) after 14 years of services in pursuance to the order dated 12.08.2024 passed by the Hon'ble High Court of HP in CWP No. 8064/2024 subject to final outcome of SLP Filed in the Hon'ble Supreme Court in CWPOA No. 5536/2020 titled as Sanjay Kumar & ors. V/s State of H.P. But, since, the Hon'ble Supreme Court has now stayed the implementation/ execution of Hon'ble High Court order passed in Sanjay Kumar V/s State of H.P. case hence, can't be allowed the re-revised grade pay till the final outcome of case.

Therefore, in view of the above facts the claim of petitioners to step up their pay after allowing the 14 years benefit under ACPs (4-9-14), at par with their junior Sh. Gyar Singh Negi does not seem fit at this point and can't be allowed the re-revised grade pay till the final outcome of case. Hence, the representation of the petitioner is decided and disposed of accordingly. May inform the parties accordingly.
