ORDER

In the matter of: CWP No. 11777/2025 titled as Basanti, LT vs. State of H.P. & others (Reg. Transfer).

Smt. Basanti, LT is under order of transfer from GSSS Udaipur, L&S to GSSS Gulling, Spiti as per the compliance in CWP No. 9675/2025 titled as Rema Kumari (Regarding transfer). The petitioner has filed a CWP No. 11777/2025 titled as Basanti, LT vs. State of H.P. & others (Reg. Transfer), wherein the Hon'ble High Court of Himachal Pradesh was pleased to pass the following orders:-

"6. Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with a direction to Director, School Education, Himachal Pradesh, to consider and decide the pending representation of Sher Singh for his transfer from Government Senior Secondary School Salgran, Lahaul, District Lahaul & Spiti, to Government Senior Secondary School Gulling, Spiti, District Lahaul & Spiti, Himachal Pradesh and in case said request is accepted by the department, petitioner herein, who vide order dated 18.07.2025, has been ordered to be transferred to Government Senior Secondary School Gulling, Spiti, District Lahaul & Spiti, Himachal Pradesh, may be posted at Government Senior Secondary School Salgran, Lahaul, District Lahaul & Spiti. Ordered accordingly. Needful in terms of instant order, shall be done expeditiously preferably with ten days and till then, petitioner shall not be compelled to join at transferred station. Pending applications, if any, stand disposed of."

That in compliance to the directions of the Hon'ble High Court of H.P. Smt. Basanti, LT and Sh Sher Singh, LT has submitted representations through DDSE, Lahaul at Keylang. In representation petitioner Smt Basanti, LT has requested that due to her adverse family circumstances she may kindly be adjusted in school nearby lahaul region and Sh Sher Singh, LT has submitted that he is presently working as LT in GSSS Salgran, Lahaul region since 5 years and is willing to transfer to GSSS Gulling.

As per the report received from DDSE, Lahaul and spiti, it is revealed that petitioner, Smt Basanti, LT is under order of transfer from GSSS Udaipur, L&S to GSSS Gulling, Spiti as per the compliance in CWP No. 9675/2025 titled as Rema Kumari (Regarding transfer). Sh Sher Singh presently working as LT at GSSS Salgran, Lahaul region, District Lahaul and Spiti has been appointed as LT on 28.10.2019 on contract basis and his services were regularized on 12.04.2022. He has completed his 3 years of normal tenure at present place of posting.

In view of the facts narrated above, the representation of petitioner Smt Basanti, LT and Sh Sher Singh, LT is hereby considered sympathetically and Sh. Sher Singh is transferred from GSSS Salgran, Lahaul, District L&S to GSSS Gulling, Spiti, District L&S in place of Smt. Basanti, LT who is under order of transfer from GSSS Udaipur to GSSS Gulling and a result of this Smt. Basanti can automatically be adjusted at GSSS Salgran, Lahaul, District L&S. All the concerned are to be intimated accordingly. The Dy. Director of School Education Lahaul at keylang and Spiti at Kaza is directed to take further action in this connection under intimation to this Directorate.
