COPC No. /25 in CWP No. 15205/2025 titled as Rajiv Rathore V/s State of H.P. (Regarding grant to the petitioner the benefit of higher stage of pay of Rs. 41600/from the date the petitioner have completed two years regular on analogy of Inder Singh Thakur.)

That the petitioners have filed the present Civil Writ Petition thereby seeking the relief to the extent that a writ of mandamus or any other direction may kindly be issued to the respondents to grant to the benefit of higher stage of pay of Rs. 41600/- from the date petitioner has completed two years of regular services in terms of the judgment passed by the Hon'ble High Court in CWP NO. 4830/2023 titled as Inder Singh Thakur & Ors. V/s State of H.P. and further respondents directed that the petitioner be re-fixed from the date petitioner have completed two years of their respective regular services and to release all consequential benefit alongwith arrear at the rate of 9% per annum.

The said case was listed before the Hon'ble High Court of H.P. on 22.09.2025 when the following orders were passed:-

"Consequently, in view of the above, the present petition is disposed of with a direction to the respondents to consider and decide the representation (Annexure P-4) of the petitioners in light of judgment, as detailed hereinabove, expeditiously, preferably within a period of four weeks. In case, petitioners are found to be similarly situate to the petitioners in the aforesaid judgment, they would be extended similar benefits. Needless to say, authority concerned while doing the needful in terms of the instant order shall afford an opportunity of hearing to the petitioners and pass speaking order thereupon. Pending applications, if any, also stand disposed of.. "

WHEREAS, as per information received from concerned DDSE, the petitioners were initially appointed TGT's on PTA contract basis in year, 2015 and their services were regularized in the year 2020. However, the services of the petitioner were reguralised w.e.f. 01.04.2018 as per order of the Hon'ble High Court passed in CWP No. 342/2021 titled as Yashwant Singh & ors. and connected matter. It is pertinent to mention here that the petitioners were appointed as TGT on contract basis in the pay scale of 10300-34800+3600 followed by the regular appointement to the post of TGT. The said petitioners filed CWP 15205/2025 before the Hon'ble High Court of H.P. to seek the benefit of higher grade pay after two years of their regular services on the analogy of Inder Singh Thakur.
