ORDER

In the matter of CWP No. 10295/2025 titled as Surender Singh Chauhan V/S State of HP and others.

Whereas, Sh. Surender Singh Chauhan, Senior Assistant, O/o BEEO Dadasiba, District Kangra, filed the aforesaid CWP before the Hon'ble High Court of Himachal Pradesh, challenging his transfer from the O/o Block Elementary Education Officer, Dadasiba to the O/o Block Elementary Education Officer, Ronhāt, District Sirmour.

And whereas, the Hon'ble High Court disposed of the petition on 27.06.2025, with the following directions:

"Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee to seek transfer/adjustment at a convenient station on adverse family circumstances. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order."

And whereas, in compliance with the above directions, Sh. Surender Singh Chauhan was heard in person on 29.07.2025. During the hearing, the official submitted that he suffers from health issues requiring regular follow-up and advanced medical supervision, which is currently available only in urban areas. He, therefore, requested adjustment in O/o BEEO Gagret-I/Gagret-II/Amb, against a vacant post of Senior Assistant.

And whereas, on perusal of the staff position, it has been found that there is a shortage of ministerial staff in the O/o BEEO Gagret-I. Presently, only three officials are posted there, including two Superintendents Grade-II and one Clerk, while one post of Supdt. Gr.-II, five posts of Senior Assistants, and eight posts of Clerks are lying vacant in the said office.

therefore, considering the applicant's Now, representation sympathetically, Sh. Surender Singh Chauhan, Senior Assistant, is hereby adjusted in the O/o BEEO Gagret-I, District Una, against a vacant post of Senior Assistant, without TTA/joining time.
