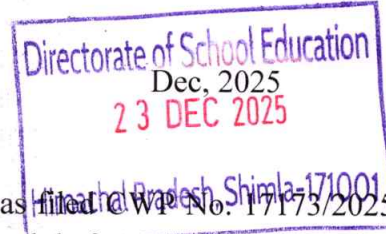

**ORDER**

Whereas, Ms. Manisha Singh, JBT has filed CWP No. 17173/2025 before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 06.11.2025, when after the hearing Hon'ble High Court has passed order as under:-

*"True it is that it is the sole prerogative of the employer to post an employee anywhere in the state, but fact remains that transfer policy formulated by State of Himachal Pradesh, enables an employee to seek transfer on the ground of couple case as well as adverse family circumstances, as such, this court sees no impediment in as much as issuing direction to the respondents to consider and decide representation of the petitioner, expeditiously, preferably, within three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy as well as taking note of the fact that Department, who at present is posted in District Kangra. Pending applications, if any, also stand disposed of"*

Whereas, as per the orders of Hon'ble High Court of H.P., after examining the petitioner's representation dated 21.11.2025 submitted by the petitioner and after perusal of comments submitted by the DDEE Chamba, revealed that the petitioner Ms. Manisha Singh, JBT has been working at GPS Tatri, EB Mehla-I, Distt. Chamba since 29.09.2022 and has been serving sub cadre at present place of posting 29.09.2022 to till date. The petitioner sought her transfer on the ground of couple case as well as adverse family circumstances and has requested for her transfer to one of the vacant stations i.e. (1) GPS Barour, EB Chamba-I (2) GCPS Kiri, EB Mehla-II (3) GPS Sahluien EB Chamba-I, Distt Chamba.

Keeping in view of above facts, the representation of the petitioner is examined sympathetically and after due consideration, the Deputy Director of School(Elementary) Education Chamba is hereby directed that the petitioner, Ms. Manisha Singh, JBT at GPS Tatri, EB Mehla-I, Distt Chamba may be transferred to GCPS Kiri, EB Mehla-II, Distt Chamba against vacant post. **The concerned DDEE is directed that the transfer orders, be implemented after the completion of ongoing academic session.**

Hence, the representation of the petitioner stands decided and disposed of, accordingly.
