Regarding withdraw the benefit released in compliance to the judgmnent passed in LPA 4059/2013 in CWP No. 3144 of 2011-Anju Devi, LPA No. 4060/2013 in CWP No. 3143/2011- Manju Devi and O.A. No. 5561/2015 titled as Tej Ram & ors. vs. State of HP and ors.

Sir,

In continuation to this office letter No. EDN-H(2)B(2)54/2013-CC dated 28.03.2025 whereby it has been ordered that the petitioners of those petitions which are decided on the analogy of CWP No. 414/2014 titled as Kuldeep Chand Vs State of HP & ors. (connected with ... LPA No. 54/2013 titled as State of Himachal Pradesh & Ors. vs. Om Prakash alongwith LPA No. 21/2013 filed in CWP No. 7602 of 2010 titled as Om Prakash Versus State of H.P. and others & LPA No. 4059/2013 & LPA No. 4060/2013) and all other connected matters, whose services have been regularized after 12th December, 2003 cannot be considered deemed regularized from the date of their initial appointment/joining on contract basis and hence not entitled for any other service . benefits such as Seniority, increment, promotion etc. as the petitioners have not been appointed on regular basis as per provisions of "The Himachal Pradesh Recruitment and conditions of Service of Government Employees Act, 2024" (Act No. 23 of 2025) dated 19th February, 2025.

In this context, it is reitreated that these orders shall applicable to all TGTs as well as C&V category teachers and the benefit released to the petitioners in compliance to the judgmnent passed in LPA 4059/2013 in CWP No. 3144 of 2011-Anju Devi, LPA No. 4060/2013 in CWP No. 3143/2011- Manju Devi and O.A. No. 5561/2015 titled as Tej Ram & ors. vs. State of HP and ors. shall stand withdrawn with immediate effect.

Further, it is also brought to your kind notice that the petitioners (LTs/Shastries) whose services were regularized w.e.f. 2009 onwards on the analogy of above judgments are now claiming the benefit of TGT Scale on the analogy of judgment passed in CWP No. 3341/2019 titled as Madan Lal, CWP No.6582/2019 titled as Prem Sukh and CWP (T) No. 5759/2008 titled as Subhash Chand & anothers and all other similar situated decision.

Hence, the cases/representations of all the petitioners as well as non petitioners in the category of C&V (i.e. LT/Shastri) whose services were considered as regular from the date of initial appointment on contract basis as well as for granting the TGT Scale may be rejected accordingly. It is further ordered that if any such benefits have already been extended to any person/persons, may also be withdrawn with immediate effect.
