ORDER

In the matter of:-

CWP No. 10405/2025-titled as Prince Kumar Sharma, TGT (Arts) V/s. State of HP.

The petitioner transfer order dated 27.06.2025 was issued from GSSS Mehal Distt. Hamirpur to GHS Dolan u/c GSSS Bassi Distt. Bilaspur vice Ms. Usha Devi, TGT (Arts). Feeling aggrieved, petitioner Sh. Prince Kumar Sharma, TGT (Arts) has filed present CWP in the Hon'ble High Court and sought his adjustment. The case was listed before the Hon'ble High Court of H.P. on 31.07.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"However, having taken note of fact that father of the petitioner has become 85% disabled on account of amputation of his both legs, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer on account of adverse family circumstances, this Court, without going into the merits of the case, deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation to the competent authority within two days for his adjustment at a convenient station i.e. i.e. GSSS Boys, Hamirpur, Himachal Pradesh or any nearby station, which shall be decided by the competent authority sympathetically, preferably within two weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of fact that petitioner has already served in sub cadre area i.e. GSSS Kothi Lahor, Chota Bhangal, Tehsil Multhan, District Kangra, for more than three and a half years. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order."

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner has stated that both the legs of his father have been amputated because of CANCER, as a result thereof, petitioner father has become 85% disabled. Since there is none to take care of his father, petitioner is required to be posted nearby station i.e. GSSS Bharthian/GSSS Boys Hamirpur Distt. Hamirpur.

From the perusal of record, it is found that Sh. Prince Kumar Sharma, TGT (Arts) is working at GSSS Mehal Distt. Hamirpur since 16.9.2023 and has not completed his normal tenure at present place of posting. At present post of TGT (Arts) is lying vacant at GSSS Bharthian Distt. Hamirpur wherein 55 students are enrolled.

In view of above narrated circumstances, the representation of petitioner has been considered sympathically and the petitioner i.e. Sh. Prince Kumar Sharma, TGT (Arts) who is under order of transfer from GSSS Mehal Distt. Hamirpur to GHS Dolan u/c GSSS Bassi Distt. Bilaspur is hereby adjusted at GSSS Bharthian Distt. Hamirpur against vacancy (without TTA/JT). The representation of the petitioner in the present CWP stands disposed of. All the concerned be intimated accordingly.
