ORDER

In the matter of:- CWP No. 17007/2025-titled as Meena Kumari, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 17007 of 2025 in the Hon'ble High Court vide which sought her transfer from GSSS Bosari Distt. Shimla (i.e. sub cadre/hard area) to soft area. The present CWP was listed before the Hon'ble High Court of H.P. on 31.10.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 21-11-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Smt. Meena Kumari, TGT (Arts), submitted fresh representation and stated that she is working at GSSS Bosari Distt. Shimla (sub cadre area) and completed her normal tenure at present place of posting so that requested for transfer/adjustment at GSSS Purla Distt. Solan, GSSS Galore, GSSS Rail Distt Hamirpur.


From the perusal of the record, it is found that Smt. Meena Kumari, TGT (Arts), is posted at GSSS Bosari Distt. Shimla (i.e. Sub cadre area) since 23.02.2022 and completed her normal tenure at present place of posting. At present all posts of TGT (Arts) are lying vacant at GSSS Domehar Distt. Solan, wherein about 83 students are enrolled and the institution GSSS Domehar, is situated in a soft area of District Solan.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right." Therefore, Smt. Meena Kumari, TGT (Arts) is hereby transferred from GSSS Bosari Distt. Shimla to GSSS Domehar Distt. Solan(soft area) against vacancy, without TTA/JT in the larger interest of the students. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
