**ORDER**

In the matter of: CWP No. 13803/2025- Sh. Vijay Singh, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Vijay Singh, TGT(NM) presently working in GMS Khauncha u/c GSSS Koti Bounch, Distt. Sirmour has filed CWP No.13803/2025 titled as Vijay Singh Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Khauncha u/c GSSS Koti Bounch, Distt. Sirmour to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 27.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of the fact that many station have become available/vacant on account of promotions of the TGTs to the post of Lecturer School Cadre as is evident from office order (Annexure P-6). Pending applications, if any, also stand disposed of."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 15.09.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Khauncha u/c GSSS Koti Bounch, Distt. Sirmour to GSSS Barot or GMS Badukhar u/c GSSS Badhadpur or GMS Upper Nari u/c GHS Ghati Bilwan, Distt. Kangra, against vacancy.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Khauncha u/c GSSS Koti Bounch, Distt. Sirmour since 01.03.2021 on regular basis and has completed his normal tenure of three years. At present, one post of TGT(NM) is lying vacant at Upper Nari u/c GHS Ghati Bilwan, Distt. Kangra.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Khauncha u/c GSSS Koti Bounch, Distt. Sirmour to Upper Nari u/c GHS Ghati Bilwan, Distt. Kangra, against vacancy without TTA/JT as per his request.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
