The Petitioner Smt. Mangla Devi, TGT (Med) filed CWP No. 10164/2025 titled as, Smt. Mangla Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Kamlar Distt. (Smr.) to Distt. (Hamirpur). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 26.06.2025 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

Having regard to the above submissions, the instant writ petition is disposed of by directing the respondents/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law and applicable transfer policy, while keeping in view the adverse family circumstances pointed by the petitioner, within a period of ten days from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court the petitioner was called for personel hearing on dated. 17.07.2025. The petitioner attended the personal hearing and has requested to adjust him at District Hamirpur.

From the perusal of record, it is found that Smt. Mangla Devi, TGT (Med.) is working in GSSS, kamlar Distt. (Smr.) since 24.02.2022. GSSS, kamlar Distt. (Smr.) falls in soft area of Distt. Sirmour.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
