Whereas, Sh. Piar Chand, TGT (NM) previously working in GHS Jumhar u/c GSSS Luddu, Distt. Chamba has filed CWP. No. 8102/2025 titled as Sh. Piar Chand TGT (NM) Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted from at one of the stations of his choice in Distt. Kangra/Chamba. The case of the petitioner was listed before the Hon'ble High Court on 16.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

4. "Keeping in view the aforesaid submissions and without interfering with the transfer of respondent No.4 under the impugned office order, this writ petition is disposed of by permitting the petitioner to prefer a representation for his transfer/adjustment to the competent authority/Director of School Education, Himachal Pradesh, within two days from today. In case such a representation is so preferred within the aforesaid period, the same shall be considered and decided by the competent authority in accordance with law and applicable transfer policy within a period of one week thereafter. The decision so arrived at shall also be communicated to the petitioner.

Till such decision, the petitioner shall be at liberty to avail leave of the kind due. It is made clear that in case no such representation is made within the aforesaid period, interim protection granted to the petitioner shall stand automatically vacated.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any".

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted in GSSS Ghaniara or GSSS Dharmshala or GHS Ladwara or GSSS Kanol or GHS Kaled, Distt. Kangra or GSSS Hatli, Distt. Chamba against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GHS Jumhar u/c GSSS Luddu, Distt. Chamba to GMS Rajindu u/c GMSSS Saho, Distt. Chamba vice Sh. Vipan TGT (NM) with TTA/JT vide this directorate letter No. EDN –H(2)B(6)-1-18/2024(NM)-dated 06.05.2025 with the prior approval of the competent authority. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.

Whereas, Ashwani, TGT (NM) presently working in GSSS Kuddu, Distt. Shimla has filed CWP. No. 8581/2025- titled as Ashwani, Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Kuddu, Distt. Shimla to one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 23.05.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

5. Consequently, in view of the above, present petition is disposed of with a direction to the respondents to decide the pending representation (Annexure P-1) expeditiously, preferably, within three weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order, taking note of transfer policy, which provides for cancelation/adjustment of an employee on account of adverse family circumstances. Pending applications, if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.06.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Kuddu, Distt. Shimla to GSSS Hatwas or GMS Barai u/c GSSS Nagrota Bagwan or GHS Mumta or GSSS Baldhar, Distt. Kangra, due to his adverse family circumstances

After perusal of the relevant record, it is revealed that the petitioner was appointed as TGT (NM) on contract basis on 21.02.2022 at GMS Jharashli u/c GSSS Jhagtan, Distt. Shimla further adjusted at GSSS Kuddu Distt. Shimla as his previous School de-notified due to less enrollment GMS Jharashli and joined GSSS Kuddu Distt. Shimla on 11.09.2024 Though the said teacher has completed her normal tenure of three years at GMS Jharashli and GSSS Kuddu Distt. Shimla but at present 60 students are studying there. GSSS Kuddu falls in soft area. Keeping in view the studies of the students studying at GSSS Kuddu, Distt. Shimla it shall not be feasible to transfer the petitioner because in the absence of TGT (NM) the studies of students, will be affected adversely. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 8376/2025-titled as Shashi Kumar, TGT (Arts) V/s State of H.P. on 21-05-2025, the petitioner was called for personal hearing on 18-06-2025 and appeared before the undersigned on scheduled date.
