In the matter of: CWP No. 8393/2025 titled as Sujan Singh, TGT (NM) Vs. State of H.P. & ors.

Whereas, Sh. Sujan Singh, TGT (NM) preferred CWP No. 8393/2025 titled as Sujan Singh Vs. State of H.P. before the Hon'ble High Court of H.P. Who is under order of transfer from GSSS Kanol, Distt. Kangra to GSSS Jharmajari, Distt. Solan be adjusted at GMS Barai u/c GGSSS Nagrota Bagwan, Distt. Kangra against longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22.05.2025 when the Hon'ble High Court has passed the following orders:-

"Since by way of CWP No. 4517 of 2025, petitioner herein had approached this Court, seeking therein direction to consider his representation to transfer him from GSSS Kanol to a convenient place taking note of the medical condition and this Court taking note of the Averments contained in the petition, has directed the respondent to consider and decide pending representation expeditiously, preferably, within four weeks and till date, representation filed by the petitioner has not been decided, there appears to be justification for this Court to stay the impugned transfer order, whereby petitioner has been transferred from GSSS Kanol to GSSS Jharmajari. In view of the above, it is ordered that operation of impugned transfer order dated 16.05.2025 (Annexure P-6) Shall remain stayed qua the petitioner pending reply from the respondents."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 17.06.2025 vide which the petitioner who is under order of transfer from GSSS Kanol, Distt. Kangra to GSSS Jharmajari, Distt. Solan may be adjusted at GMS Barai u/c GGSSS Nagrota Bagwan, Distt. Kangra, against longer stayee.

From perusal of record, it has been found that the petitioner who is under order of transfer from GSSS Kanol, Distt. Kangra to GSSS Jharmajari, Distt. Solan. One Sh. Mool Chand TGT (NM) is working in GMS Barai u/c GGSSS Nagrota Bagwan, Distt. Kangra since 05.05.2021. The petitioner has given willingness for his adjustment to the aforesaid school against longer stay. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby adjusted at GMS Barai u/c GGSSS Nagrota Bagwan, Distt. Kangra vice Sh. Mool Chand, TGT (NM) without TTA/JT and Sh. Mool Chand TGT (NM) is hereby transfer from GMS Barai u/c GGSSS Nagrota Bagwan, Distt. Kangra to GSSS Jharmajri, Distt. Solan with TTA/JT. The representation of the petitioner is disposed of accordingly.
