ORDER

In the matter of : CWP No. 9873/2025 titled as Diwan Chand, LT vs. State of H.P. & others (Reg. Transfer).

Sh. Diwan Chand, LT is working as LT at GSSS Chotta Shimla, District Shimla and is under order of transfer to GSSS Kanda Banah, Shimla. The petitioner has filed a CWP No. 9873/2025 titled as Diwan Chand, LT vs. State of H.P. & others, wherein the Hon'ble High Court of Himachal Pradesh was pleased to pass the following orders:-

"5. Though, having taken note of the fact that petitioner has already completed normal tenure of posting at present place of posting, there appears to be no justification for this Court to interfere with the impugned transfer order, however having taken note of U.O. note dated 20.05.2025 (Annexure P-4), whereby Hon'ble Education Minister taking note representation filed by the petitioner, directed/ordered for adjustment of the petitioner at Government Senior Secondary School Patgehar Shimla or Government Senior Secondary School Tutikandi, District Shimla, Himachal Pradesh, this Court deems it fit to dispose of present petition with a direction to respondents to take final decision upon the recommendation made by Hon'ble Education Minister (Annexure P-4) sympathetically expeditiously, preferably within a period of one week. Till the time, decision in terms of instant order is not taken, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

That in compliance to the directions of the Hon'ble High Court of H.P. the petitioner was called for personal hearing on 23.06.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner has requested that he may kindly be adjusted at GSSS Dhalli, District Shimla against vacancy being caused due to superannuation of present incumbent on 31.08.2025.

That the matter has been examined on the basis of report received from the Deputy Director of School Education, Shimla which revealed that the petitioner was appointed as LT on 02.04.2012 on contract basis and is regularized on 31.05.2017. He is under order of transfer from GSSS Chotta Shimla to GSSS Kanda Banah, Shimla. At present, Smt. Pushpa, LT is posted at GSSS Dhalli, Shimla who is going to be retired on 31.08.2025.

In view of the facts narrated above, the representation of **Sh. Diwan Chand**, **LT** is hereby considered sympathetically and is hereby adjusted at **GSSS Dhalli**, **District Shimla**, against vacant post being caused due to superannuation of present incumbent on 31.08.2025 without **TTA/JT**. The petitioner may be relieved after 31.08.2025.

Whereas, Deeksha, TGT (NM) preferred COPC No. 544/2025 in CWP No.7051/2025 titled as Deeksha Vs. 4. "Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents/competent authority to consider and decide representation (Annexure P-2) of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of clause 5.2 of the transfer policy. Liberty is also reserved to the petitioner to file appropriate proceedings before the appropriate court of law if she still remains aggrieved. Pending applications, if any, stand dispsed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted her representation in this office on 21-06-2025, vide which She has requested that She may be transfer from GMS Lohani, U/C GMSSS Salooni, Distt. Chamba, H.P to nearby her native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms.

From perusal of record, it has been found that the petitioner has been working at GMS Lohani, U/C GMSSS Salooni, Distt. Chamba, H.P since 22-02-2022 and has completed his normal tenure at present place of posting. One Sh. Rajinder Kumar, TGT(NM) is working in GSSS Saura Distt. Kangra, H.P since 01.02.2022. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and She is hereby transfer from GMS Lohani, U/C GMSSS Salooni, Distt. Chamba, H.P to GSSS Saura Distt. Kangra, H.P vice Sh. Rajinder Kumar, TGT(NM) against longer stayee. with TTA/JT to Sh Rajinder Kumar, TGT(N.M). The representation of the petitioner is disposed of accordingly.

CWP No. 5175/2025 titled as Santosh Kumar (LT) Vs. State of HP & Ors.

Whereas, Santosh Kumar (LT) who is presently working in GSSS Bhatkidhar, Distt. Mandi which is a hard/difficult area has filed CWP No. 5175/2025 before the Hon'ble High Court of HP. The Hon'ble High Court of HP has disposed off above court case on 07.04.2025. Operative part of the Judgment is as under: -

4. Consequently, in view of the above, this Court without going into the merits of the case deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while affording opportunity of hearing to the petitioner shall also take note of the transfer policy formulated by the Government of Himachal Pradesh, which provides for transfer of an employee from hard area to soft area after his/her having completed normal tenure of posting i.e. two summers and three winters and pass appropriate orders. Pending applications, if any, also stand disposed of.

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.06.2025 by the undersigned and the petitioner attended the personal hearing on the scheduled date & time and was heard at length. During the course of hearing, the petitioner who is working in GSSS Bhatkidhar, Distt. Mandi has requested to transfer him to GSSS Khnot-Gopalpur-1, Kumari Sailbala Govt. Model Senior Secondary School, Baldwra, GSSS Trifalghat, GHS Sulpur Bahi or GGSSS, Mandi.

After perusal of the relevant record, it reveals that the petitioner is presently working in GSSS Bhatkidhar, Distt. Mandi w.e.f. 27.01.2022 which is a hard/difficult area. Also it revealed that post of the Language Teacher is not vacant in the stations proposed by the petitioners. But in G (G)SSS Mandi one post of Language Teacher is going to vacant after retitrement of the present incumbent on 30.06.2025.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred to G (G)SSS Mandi, Distt. Mandi, against vacancy being caused due to retirement of Smt. Neeta Dhawan on 30.06.2025 on his own request without TTA/JT.

The representation of the petitioner is disposed of after due consideration. All the concerned intimated accordingly.
