ORDER.

& others.

The Petitioner Sh. Viiav Singh, TGT(Med)) filed CWP No. 11426/2025 titled as, Sh. Vijay Singh, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS, Chari U/c GSSS, Mehla Distt. (Chamba) to GHS. Malhanta U/c GSSS, Diana/GSSS, Manoh Sihal/GSSS, Badiali Distt. (Kgr.) against longer stavee. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 17.07.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2. Competent Authority to consider and decide the aforesaid representations of the petitioner in accordance with law and as per applicable notification/policy within a period of three weeks from today. The decision so taken he also communicated to the peitioner."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 15.09.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing he has requested to adjust him at above mentioned school in Distt. Kangra.

From perusal of the record, it is observed that Sh. Vijay Singh, TGT (Medical), has been serving at GHS, Chari U/c of GSSS Mehla. District Chamba, since 30.05.2022. He has completed the normal tenure at his current place of posting in the sub-cadre area. Sh. Vijay Singh has requested for adjustment against a longer stayee. However, considering that the current academic session is ongoing, such a transfer may disrupt the academic progress of the students. It is also noted that presently, one post of TGT (Medical) is lying vacant at GGSSS, Jawali, District Kangra.

Keeping in view the position stated above, representation of the petitioner i.e. Sh. Vijay Singh. FGT (Med.) is considered sympathetically and hereby transferred from GHS. Chariu/c GSSS Mehla Distt. (Cba.) to GGSSS, Jawali Distt. (Kgr.) against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly. Directorate of School Education

ORDER

CWP No. 14034/2025-titled as Tek Chand, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from PM Shri GUSSS Jarol Distt. Mandi (HP) to one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 01-09-2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 10.09.2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Tek Chand, TGT (Arts), submitted that he is facing adverse family circumstances, as his father, aged about 81 years, is suffering from multiple age-related ailments. He further stated that his wife is a Government employee and, in the absence of any other family member to look after his father, he has requested his transfer to GSSS Jaidevi, GSSS Tawan or GHS Dharnda under GSSS Meramasit, District Mandi.

From the perusal of record, it is found that Sh. Tek Chand, TGT (Arts), is working at GSSS Jarol Dist. Mandi and at present one post of TGT (Arts) is lying vacant at GMS Ner u/c GSSS(G) Bhangrotu Dist. Mandi wherein 35 students are enrolled. Keeping in view the position stated above, representation of the petitioner is considered sympathetically as per transfer policy clause 5.4 "concession to couples case" working under H.P. Government and petitioner i.e. Sh. Tek Chand, TGT (Arts) is hereby transferred/adjusted from PM Shri GUSSS Jarol Distt. Mandi to GMS Ner u/c GSSS(G) Bhangrotu Distt. Mandi against vacancy (without TTA/JT).

The representation of the petitioner in the present CWP stands disposed of. All the
