ORDER

In the matter of:- CWP No. 20970/2025-titled as Suneel Sharma, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 20970 of 2025 in the Hon'ble High Court vide which sought his transfer from GSSS Giltari Distt. Shimla to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 30.12.2025, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

“Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation and reminder of the petitioner dated 27.08.2025 & 11.12.2025 (Annexures P-2 & P-3, respectively) in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner.”

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24.01.2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Suneel Sharma, TGT (Arts), submitted fresh representation and stated that he is working at GSSS Giltari Distt. SHimla (i.e. soft area of Distt. Shimla) and requested for transfer/adjustment at either at GSSS Manjholi, GSSS Dabhota, GSSS Rajpura Distt. Solan on account of completion of normal tenure of posting.

From the perusal of the record, it is found that Sh. Suneel Sharma, TGT (Arts), has been working at from GSSS Giltari Distt. Shimla since 23.03.2022 on contract basis and his services were regularized vide this Directorate letter dated 28.04.2025. Further the institution GSSS Giltari, is situated in a soft area of district Shimla, wherein about 37 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right.” Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner (Sh. Suneel Sharma, TGT (Arts) is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Giltari Distt. Shimla. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
