ORDER

Whereas, Sh. Dharam Chand, Lecturer (School-New) (Economics) has filed CWP No. 10030/2025 before the Hon'ble High Court against his transfer from GSSS Katrain (KLU) to GSSS Hallan (SMR) against vacancy by clubbing his previous stay within the radius of 30 Kms in public interest issued vide this office order dated 04.06.2025 as pleaded that he has been transferred to a specific place only on the basis of recommendations of respondent No.5 and the case was listed before the Hon'ble High Court on 23.06.2025 and Hon'ble High Court stayed the said orders.

The case was finally listed before the Hon'ble Court on 10.07.2025 when the case was disposed of with the following directions:-

"The respondents have not denied transferring the petitioner from District Kullu to District Sirmour on the basis of recommendations of respondent No.5. Even though as per the office instructions placed on record by the respondents, the petitioner has served in District Kullu w.e.f. the year 2002 till date, therefore, he is liable to be transferred outside District Kullu, yet taking note of the fact that his present transfer to District Sirmour is only on the basis of recommendations made by respondent No.5, this writ petition is disposed of by quashing the impugned office order dated 04.06.2025 (Annexure P-1), but granting liberty to the respondents/competent authority to consider the case of the petitioner for transfer-afresh in accordance with law after independent application of mind."

And whereas, as per directions passed by the Hon'ble High Court on 10.07.2025 it is found that petitioner is serving in Distt. Kullu since 2002 and he never served outside Distt. Kullu as well as his home district and also not served in Tribal/Hard area etc. Hence, he should serve elsewhere in the state and now he is liable to transfer outside Distt. Kullu.

Now therefore, after taking into account of the above facts and circumstances of the case petitioner i.e. Sh. Dharam Chand, Lecturer (Economis) is being transferred from GSSS Katrain (KLU) to GSSS Khera, Distt. Kangra against vacancy with TTA/JT.

May inform the parties accordingly please.
