TERMS AND CONDITIONS FOR DISPOSAL OF OLD/CONDEMNED ARTICLES

The deposit must be made at the Store Branch of the Directorate of School Education, Shimla-1.on or before 25.08.2025 (up to 12 Noon) failing which bidder shall not be considered for participation in auction process to be held on the same day at 3:00 PM.
- 3. The disposal of old/condemned articles shall be strictly on "AS IS WHERE IS BASIS" and no guarantee of certificate of its worthiness or quality will be given by the Department.
