Whereas, Kamla Devi, TGT (NM) presently working in GMS Bulang u/c GSSS Dharmehar, Distt. Mandi has filed CWP. No. 9979/2025- titled as Kamla Devi, TGT (NM). Vs. State of H.P. and others before the Hon'ble High Court, seeking the relief that she may be transferred from GMS Bulang u/c GSSS Dharmehar, Distt. Mandi to one of the stations of her choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 21.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Having taken note of the fact that petitioner has already completed normal tenure of posting at present place of posting, coupled with the fact that transfer policy provides for minimum tenure of three years at one station and father-in-law of the petitioner is seriously ill, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation (Annexure P-2)of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy framed by the Government of Himachal Pradesh. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Bulang u/c GSSS Dharmehar, Distt. Mandi to GMS Nagan u/c GSSS Urla Drang-II or GSSS Urla Drang-II or GMS Ghatasni u/c GSSS Gumma Drang-I against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Bulang u/c GSSS Dharmehar, Distt. Mandi since 28.08.2023. The said teacher has not completed her normal tenure of three years at present place of posting as per transfer policy, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All

## ORDER

In the matter of:

CWP No. 10983/2025 titled as Sanjeev Kumar, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Sanjeev Kumar, TGT (NM) previously working in GHS Farotka u/c GSSS Bathri, Distt. Ch;amba has filed CWP No. 10983/2025 titled as Sanjeev Kumar, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra/Chamba. The case of the petitioner was listed before the Hon'ble High Court on 09.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"5. Consequently, in view of the above, this Court finds merit in the present petition and accordingly the same is allowed. Impugned order dated 07.07.2025 (Annexure P-4) is quashed and setaside with the direction to Director, School Education, to decide the representation of the petitioner afresh, taking note of observations made hereinabove and in case it is verified that petitioner has served in hard/tribal area in past, then he shall not be transferred again to hard area, rather, shall be provided some soft station. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order thereupon taking note of Transfer Policy, formulated by the Government of Himachal Pradesh, relevant provisions whereof have been already discussed hereinabove. Since petitioner has been fighting for his rightful claim for quite long, this Court hopes and trusts that needful in terms of instant order shall be done on or before 18.07.2025. Till then, petitioner shall not be compelled to join the transferred station and he may avail leave of kind due. In the aforesaid terms, present petition is disposed of along with pending application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 23.07.2025 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Ranger u/c GSSS Bhagdhar or GMS Jakhara u/c GSSS Fatehpur or GSSS Barot or GSSS Maira or GHS Dhalog u/c Banikhet or GSSS Harnota, Distt. Chamba/Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred GHS Farotka u/c GSSS Bathri, Distt. Chamba to GMS Lothal u/c GHS Choori, Distt. Chamba vide order dated 05.05.2025 with the prior approval of competent authority. One, Sh. Vishal Kumar has been working in GMS Ranger u/c GSSS Bhagdhar since 26.03.2022 and has completed his normal tenure of three years in GMS Ranger u/c GSSS Bhagdhar, Distt. Chamba.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GMS Ranger u/c GSSS Bhagdhar, Distt. Chamba without TTA/JT vice Sh. Vishal Kumar, TGT (NM) (as he has been working there since 26.03.2022.) vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
