ORDER

Sh. Abhishek, JBT has filed CWP No. 818/2026 before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 19.12.2025, when the same was disposed of with following order.

“Learned counsel for the petitioner apprises that, being a winter-closing school, the academic session has otherwise come to an end. Learned counsel further submits that although, in the impugned order, the petitioner is stated to be deployed at Education Block Sihunta, the same is factually incorrect. The petitioner is serving at Education Block Pangi at Killar, Tehsil Pangi, District Chamba, H.P. In view of above, there shall be direction to respondent No.2/ competent authority to provide a substitute for the purpose of transferring/relieving the petitioner.”

In compliance of the above direction of the Hon'ble High Court, the petitioner was called for personal hearing on 19.02.2026. At the time of hearing, the petitioner has requested that he may be transferred from GPS Twan, E/B Pangi to GPS Naloh, E/B Sihunta, Distt. Chamba, H.P. on account of his family circumstances and as per transfer policy. On the perusal of comments submitted by the DDEE Chamba, it is revealed that the petitioner Sh. Abhishek, JBT has been working at GPS Twan, EB Pangi, Distt. Chamba at Tribal area, since 04.10.2022 and has completed his normal tenure in tribal area. The petitioner has requested for his transfer from GPS Twan, E/B Pangi, Distt. Chamba to one of the vacant stations of his choice i.e. (1) GCPS Dadriara (2) GCPS Sarog (3) GPS Naloh, E/B Sihunta, Distt. Chamba, HP. Against vacancy.

In view of above facts, the representation of the petitioner is examined after due consideration. Therefore, the Deputy Director of School (Ele.) Education, Chamba is hereby directed that the petitioner Sh. Abhishek, JBT, may be transferred from GPS Twan, E/B Pangi to GPS Naloh, E/B Sihunta, Distt. Chamba, H.P. against vacant post on larger enrollment basis and as per his own written request. The DDSE(Ele.), Chamba is further directed to post a substitute at GPS Twan first, in place of Abhishek so that the school does not remain teacher-less. The representation of the petitioner stands decided and disposed of accordingly.
