
**ORDER**

Sh. Navneet Singh JBT has filed CWP No. 20175/2025, titles as Navneet Singh, JBT Vs State of HP, before the Hon'ble High Court for his transfer. The case was listed before the Hon'ble High Court on 20.12.2025, when the same was disposed of with following order.

*“Since it is quite apparent from the pleadings as well as documents adduced on record that petitioner has already completed normal tenure at present place of posting, which is a tribal area, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from tribal area to soft area or one of the stations of his choice on his/her having completed normal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pending representations of the petitioner (Annexures P-3 & 4) expeditiously, preferably within four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders. Pending applications, if any, stand disposed of.”*

In compliance of the above direction of the Hon'ble High Court, the petitioner appeared in person on 30.01.2026 and submitted his representation for his transfer from tribal area to soft area. On the perusal of comments submitted by the DDSE(Ele.) Chamba, it is revealed that the petitioner Sh. Navneet Singh, JBT has been working at GCPS Holi, E/B Garola, Distt. Chamba, situated in tribal area, since 21.09.2024. Previously, the petitioner was serving at GPS Zuan (situated in tribal area) in E/B Garola since 24.12.2020 to 20.09.2024 and was further adjusted at GCPS Holi on account of merger of GPS Zuan. The petitioner has requested for his transfer to one of the vacant stations of his choice i.e. (1) GCPS Kathla (2) GPS Dramnala (3) GCPS Thunel, E/B Sihunta, Distt. Chamba, HP.

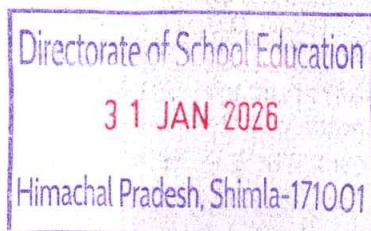
In view of above facts, representation of the petitioner has been examined after due consideration. Therefore, the/ Deputy Director of School (Ele.) Education, Chamba is hereby directed that the petitioner Sh. Navneet Singh, JBT, may be transferred from GCPS Holi, E/B Garola to GPS Dramnala, E/B Sihunta, Distt. Chamba, H.P., as per his own request against vacant post of JBT, on account of larger enrolment at GPS Dramnala, E/B Sihunta. The representation of the petitioner stands decided and disposed of accordingly.
