In the matter of: CWP No. 10424/2025-titled as Rekha Devi, TGT (Med.) V/s.
State of Himachal Pradesh and others (Regarding Transfer).

The Petitioner Smt. Rekha Devi, TGT (Med) filed CWP No. 10424/2025 titled as. Smt. Rekha Devi Vs. State of H.P. before the Hon'ble High Court of H.P against her transfer from GSSS, Loharli Distt (Hmr.) to GSSS, Baghal Distt. (Sml.) vice Smt. Reenu Pathania, TGT (Med.) The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 14.08.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"In view of above, impugned order dated 25.06.2025 (Annexure P-3) ordering vice-versa transfer of the petitioner and respondent No.4 as also office order dated 05.05.2025 (Annexure P1) to the extent it posts the petitioner at Government Senior Secondary School Loharli, are quashed and set aside. Respondent No.2 is directed to consider the respective cases of transfer of the petitioner and respondent No.4 afresh, after applying independent mind, in accordance with law and applicable transfer policy within two weeks. The order so passed be also communicated to the petitioner and respondent No.4. Till such time, the parties are allowed to continue at the places, where they are presently posted. The writ petition is disposed of in above terms. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court the petitioner and the respondent both were called for personel hearing on dated. 25.08.2025 and heard at length. The petitioner i.e. Smt. Rekha Devi TGT (Med.) has requested to adjust her at GSSS, Galore /GSSS Patta/GHS Sathwin Distt. Hamirpur or retain at GSSS Loharli District Hamirpur. Whereas, the respondent has also requested to adjust her at GSSS, Loharli Distt. (Hmr.)/GHS, Sathwin Distt. (Hmr.)/GSSS, Patta Distt. (Hmr.) or in GSSS Piploo Distt. Una against vacant post.

From the perusal of record, it is found that the petitioner Smt. Rekha Devi, TGT (Med.) has been working in GSSS, Loharli Distt. (Hamirpur.) since May 2025 and was transferred to GSSS, Baghal District Shimla on dated 25.06.2025 by clubbing her previous stay within the radius.

Keeping in view the position stated above, representation of the petitioner is considered sympathetically and the petitioner Smt. Rekha Devi, TGT (Med.) is hereby adjusted at GSSS, Galore Distt. (Hamirpur.) against vacancy, without TTA/JT on her own request. Meanwhile, Smt. Reenu Pathania is hereby adjusted at GSSS, Piploo Distt. (Una.) against vacancy, without TTA/JT. Accordingly, the representation of the petitioner, is disposed of with these observations.
