Whereas the petitioner Smt. Manisha Verma, Lect./Lect.(SN) Biology is working at GSSS Kot-Snore, Distt. Mandi w.e.f. 16.04.2021 & as such her stay is complete. Feeling aggrieved he filed CWP No 10945/2025 titled as Manisha Verma Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 09.07.2025 when the same was finally disposed with the directions to respondents as under:-

"Consequently, in view of above, present petition is disposed of with a direction to the respondents to consider and decide the representation dated 10.04.2025 (Annexure- P-1) filed by the petitioner expeditiously, preferably within four weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of transfer policy, which certainly enables an employee to seek transfer/adjustment at a convenient station on the ground of adverse family circumstances. Pending applications, if any, stand disposed of.

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that she has requested for her adjustment at GSSS Nagwain,(Mandi) against vacancy which is going to likely vacated after retirement of present incumbent on 31.01.2026.

And whereas as per direction passed by the Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on 15.09.2025 and was present on this date. During the course of hearing the applicant has pleaded that she have two young children and her father-in-law & mother are old age due to them old age ailment no one take care of both at home.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and rejected to the extent that she may represent a fresh as and when the vacancy exists as per her choice of stations and same will be decided separately as per transfer policy. Accordingly her representation stand disposed of.



O R D E R

Whereas the petitioner Smt. Suman Lata, Lect./Lect.(SN) Physics is working at GBSSS Nalagarh, Distt. Solan w.e.f. 28.04.2024 & having short stay. Feeling aggrieved she filed CWP No 14195/2025 titled as Suman Lata Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 03.09.2025 when the same was finally disposed with the directions to respondents as under:-

“Having regard to the nature of order proposed to be passed in the instant proceedings, this Court sees no necessity to call for reply from the respondents, who are otherwise represented by Mr. Vishal Panwar, learned Additional Advocate General, who states petitioner has not completed normal tenure at present place of posting and at no point of time, request, if any, ever came to be made at her behest for transfer on the ground of couple case, prayer made by the petitioner deserves outright rejection.

Though petitioner has not completed normal tenure at present place of posting, but as per learned counsel for the petitioner, she has been working within the radius of 30kms from the present place of posting, for more than 4.5 years and as such, it cannot be said that petitioner has not completed normal tenure of posting coupled with the fact that transfer policy itself enables an employee to seek transfer or adjustment at a convenient place on the ground of adverse family circumstances as well as couple case.

Since husband of the petitioner is also working in the Education Department and at present, he is posted at Govt. Middle School Mandal, Kangra, and there is none to take care of father of the petitioner, prayer made by her in as much as issuing direction to the respondents to consider and decide the pending representation in time bound manner, needs to be accepted.

Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with direction to the respondents/competent authority to decide the pending representation having been filed by the petitioner (Annexure P-1), expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy on the ground of adverse family circumstances as well as couple case. Pending applications, if any, also stand disposed of.”

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that she has requested for her adjustment either at GGSSS Dharamshala, (Kangra) against vacancy or GSSS Dari, (Kangra) against anticipated vacancy being caused due to promotion of present incumbent or GSSS Forsythganj, (Kangra) against anticipated vacancy being caused due to promotion of present incumbent or GSSS Serathana, (Kangra) against anticipated vacancy being caused due to promotion of present incumbent.

And whereas as per direction passed by the Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on 22.09.2025 and was present on this date. During the course of hearing the applicant has pleaded that she have peculiar circumstances of her family and requested that she may be adjusted/transferred at GGSSS Dharamshala, Distt. Kangra against vacancy.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and accepted and the petitioner i.e Smt. Suman Lata, Lect./Lect.(SN) Physics is being transferred/adjusted at GGSSS Dharamshala, Distt. Kangra against vacancy. Accordingly her representation stand disposed of.


