In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 6776/2025-titled as Devender Sharma, TGT (Arts) V/s State of H.P. on 25-04-2025, the petitioner was called for personal hearing on 18-06-2025 and appeared before the undersigned on scheduled date. The petitioner has stated/represented that he is under orders of transferred from GSSS Timbi to GMS Neharti Bhagot u/c GSSS Sanora (SMR) and requested for his adjustment either to GSSS Jamniwala, GMS Sharog u/c GSSS Bandli, GSSS Kandyari, GSSS Badwas, GSSS Timbi or GHS Dahar u/c GSSS Jarwa, District Sirmour.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 8243/2025-titled as Bali Ram, TGT (Arts) V/s State of H.P. on 19-05-2025, the petitioner was called for personal hearing on 18-06-2025 and appeared before the undersigned on scheduled date. The petitioner has stated/represented that he is serving as TGT (Arts) at GMS Tunda u/c GSS Mandha Tehsil Bharmour Distt. Chamba and he is seeking transfer from his present placed of posting (hard/difficult area) either to GSSS Khajjiar/Kaded/Mangla Distt Chamba, due to personal and family responsibilities seeking his transfer.

From the perusal of record, it is found that Sh. Bali Ram, TGT (Arts) is working in GMS Tunda u/c GSS Mandha Tehsil Bharmour Distt.
