In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 15427/2025-titled as Ravi Kumar, TGT (Arts) V/s State of H.P. on 19-12-2024, the petitioner was called for personal hearing on 26-04-2025 and appeared before the undersigned on scheduled date. The petitioner has stated that he has completed normal tenure in tribal area of District Chamba, therefore requested for his transfer either to GSSS Raja Ka Talab, GHS Larth u/c GSSS Raja Ka Talab, GSSS Sathana, GMS Chatta u/c GSSS Dhemeta, GSSS Kheta, GHS Baghni, GSSS Bhadwar, GHS Tikka Nagrota, GHS Polion u/c GSSS Kathiar, District Kangra, against vacancy/longer stayee.

From the perusal of record, it is found that Sh. Ravi Kumar, TGT (Arts) is working at GHS Deol Distt. Chamba (tribal area) since 24-02-2022 and has completed his normal tenure. At present post of TGT (Arts) are not lying vacant in ibid mentioned schools, however one Smt. Ambika Singh, TGT (Arts) is working at GHS Baghni u/c GSSS Bhadwar Distt. Kangra since 22.4.2021 and completed her normal tenure.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Ravi Kumar, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GHS Deol ~~Samb~~, District Chamba to GHS Baghni u/c GSSS Bhadwar Distt. Kangra vice Smt. Ambika Singh, TGT (Arts) and vice versa, (with TTA/JT to Smt. Ambika Singh, TGT, Arts). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
